Your application will be reviewed and you will be contacted for acceptance into the lodge. If you cannot provide your POST Certification Number please provide some other type of evidence that you are a peace officer in the State of Colorado. Once accepted into Lodge #100, you will be required to complete an ACH form to allow dues payment withdrawals in the amount of \$38.00 on the 5th of every month. Annual payments are the only other accepted form of dues collection. The annual amount will be prorated to the month of your application and \$456 will be due on January 1st of each year thereafter. Your application will not be forwarded to the National Lodge until this process is complete. Members in default of monthly dues payments will be allowed a 30 day grace period. If any dues in arrears are not corrected within 30 days, membership will be inactivated.
